Cruciferous vegetables broccoli and cauliflower offer sulforophane compounds known for their ability to induce phase 2 detoxifying enzymes.† Probiotic cultures provide friendly bacteria for the gastrointestinal tract and are nourished by fructooligosaccharides that selectively feed beneficial colonies of microflora. Flavonoid-rich plant extracts, lecithin and other nutrient-dense foods offer a variety of additional benefits, including antioxidant activity.†
